  - b. The applicant must have insured the vehicle to state minimum requirement.
  - c. This permit is non-transferrable.
4. Applicant must provide the following documentation:
  - a. Copy of Valid Registration Stub
  - b. Copy of Valid Insurance Card
5. Applicant agrees to submit updated registration/insurance information upon expiration of existing documents.
6. Permit will remain valid as long as:
  - a. The applicant remains the legal owner of the aforementioned vehicle.
  - b. The applicant remains a full-time resident of Marilla Country Village.
  - c. The vehicle has a valid registration and insurance, and provides updates records upon expiration.
  - d. The vehicle displays a license plate matching the registration tag.
7. Marilla Country Village, Inc. is not responsible for any damage, theft, or security of your property.
8. Any vehicle or property left without valid, written permission will be removed and/or disposed of at the owners' expense.
